

# ELECTION 2010: Shaping our future

Oregon's next Governor and Legislature will have the daunting task of getting Oregonians back to work, while preserving the quality of education, health care and other public services in the shadow of a \$1.2-billion state deficit. That's why it's important for members to participate in Election 2010 and choose wisely when casting votes.

"Oregon faces a turning point this election. AFT members provide the education necessary to drive a strong economy," said AFT-Oregon President David Rives. "Our choices in the November election are crucial to rebuilding a strong middle class in our country."

Going into the 2009 legislative session, Oregon

faced a \$4-billion shortfall. Oregon's elected officials and voters helped to lower the budget shortfall in several ways by making some hard cuts to programs; working with our members of Congress to pass a federal stimulus bill; and passing two bills that raised taxes on the wealthy and on corporations to protect education and health care programs.

"The effects of the 'Great Recession' have remained – jobs aren't returning to

the private sector and the legislature has been faced with an additional \$1.2-billion shortfall," said AFT-Oregon

Political and Legislative Affairs Director Robert Wagner. "Congress again came to our aid with the Educator Jobs bill, and state legislative leadership has worked to close the budget gap, but the 2011 session will be one of addressing fundamental revenue reform, restructuring higher education in Oregon, and working to protect benefits of public sector employees."

AFT-Oregon members carefully examined the

credentials and experience of this year's candidates. Working alongside AFT Local 6732 (OSEA), as part of the Political and Legislative Action Network (PLAN), members traveled around the state interviewing those seeking an elected position. They also reviewed candidate questionnaires, voting records for incumbents and other background information or voting records.

Only those candidates who stand by issues important to AFT members, their families and communities received recommendations for the November ballot. Party affiliation is never a consideration.



# Kitzhaber still best choice to lead Oregon's future

As a state legislator and later governor, John Kitzhaber stood by the issues important to AFT members in Oregon, including a strong commitment to education, and creating the Oregon Health Plan. He now has a longterm vision to find a cure, not apply a quick fix "band-aid," to help restore Oregon's economy, stabilize funding for quality education and health care, and get people back to work. **For these reasons and more, AFT-Oregon recommends John Kitzhaber for Governor.**

"John Kitzhaber is a known and accomplished state leader with the skills and knowledge to lead Oregonians through and beyond hard times to a vision for the state's future our members embrace," said AFT-Oregon President David Rives.

Oregon's economy flourished under Kitzhaber's leadership. Despite his opponent's claim to the contrary, some 125,000 jobs were created, compensation increased by 49 percent, economic productivity rose by 48 percent, and the unemployment rate was among the lowest in the country. He also brought together business and community leaders and elected officials to frame the Oregon Business Plan, a first of its kind effort to create jobs and grow the economy.

"I come from a family of educators and know that public education is at the heart of everything we hope to achieve as a state," said Kitzhaber. I am so proud to have the support of Oregon's education community and look forward to working together to create a system that honors teachers and invests in student success - beginning with early childhood care and education through college."

Kitzhaber has always been an avid supporter of education and health care issues. He has been a longtime advocate for health care reform and access, and saved Oregon \$2.5-million in taxpayer dollars by taking on pharmaceutical companies to win lower prescription drug costs. He also helped to create the Education Stability Fund, which has shielded schools during these dark economic times.

Since leaving office, he has worked tirelessly on health care reform. His efforts through the Archimedes Project garnered him an AFT-Oregon Award in Outstanding Contribution to Public Awareness in 2007.

**Chris Dudley**, a Connecticut native, has a "26 Point Plan" for Oregon, including corporatizing our public universities; forcing employees to pay more for PERS; and using vouchers as a way to assist our public schools. Dudley declined to fill out a candidate questionnaire, or to meet with AFT-Oregon members. The information we gathered came from his website, [www.chrisdudley.com](http://www.chrisdudley.com).

Under his plan, Dudley says one of his top priorities is to use his former "union negotiation experience" to end the six percent employer pick-up for PERS, and raise out-of-pocket health insurance contributions for public employees. He calls health and retirement benefits (PERS) for public employees a "liability," and "not sustainable."

He said he would establish an "Inspector General" within DHS to investigate waste, fraud and abuse, but fails to mention that this would duplicate services already provided by Attorney General Kroger's office, and a variety of studies that DHS has commissioned and acted on in the past 10 years.

Dudley said he would ask the Legislature to give him the authority to make specific, targeted cuts, rather than across-the-board reductions when the Legislature is not in session and revenues are lower than expected. All public programs would be subject to review and possible elimination by the Governor every six years. He said he would "establish a position in the governor's office to lead a government-wide drive to privatize state services where possible."

Dudley opposed Measures 66 and 67, and said he would stop automatically funding education at an essential budget level. He wants to lower taxes for corporations, capital gains and for wealthy Oregonians. He also opposes kicker reform to set up as a rainy day fund for education.

Dudley is best known for his 16-year career in the NBA, and moved to the Northwest when he was traded to the Portland Trailblazers, where he played for six years. He recently admitted that he moved to a home in Camas, Washington, for a time to avoid paying Oregon property taxes. After retiring from the NBA, Dudley settled with his family in Lake Oswego, and built a career in Wealth Management.

### Ted Wheeler for State Treasurer

As Multnomah County Chair, Ted Wheeler led the charge to close a \$45-million budget gap and balance the budget three years in a row, during the tough economic crisis. He said he used his "experience as a former director and manager of a firm that oversaw \$6-billion in assets, to find cost savings and efficiencies that helped the county deliver vital services like public safety, health care to the poor, libraries and senior citizen assistance."

Armed with his vast experience and expertise, Wheeler hit the ground running last March after being appointed State Treasurer in the wake of the untimely death of Ben Westlund. He is already working to make a difference in his role as Treasurer, including:

- Working to help reduce the state's budget deficit by maintaining the state's bond rating so that every possible dollar can go into services that Oregonians need.
- Helping make college accessible and affordable for Oregon's families by re-launching the Oregon College Savings Plan to make it even safer and more productive than ever.
- Overseeing the Oregon Growth Account which is responsible for investing \$100 million in state funds to start-up businesses and projects that provide economic stimulus and create jobs in our state.
  - Directing the effort to find more cost-savings in state government including compliance oversight in the treasurer's office, and independent review of internal practices.
  - Overseeing the continued, careful investment of state pension and school funds to earn the highest possible return while also protecting these funds from risk and Wall-Street-type speculation.
  - Pushing to get more funds invested in Oregon for efforts that create jobs, put Oregonians back to work and lead us out of the recession.

Congressman Kurt Schrader worked hard to accomplish the goals from his 2008 campaign, including health care reform and rebuilding America's crumbling infrastructure. He was part of the majority who approved the historic health care reform bill, signed in March by President Obama. Schrader also voted against the bank bailout, and in favor of the economic stimulus package which helped prevent the next Great Depression.

AFT-Oregon members met with Schrader to thank him for his support of the recently passed education jobs package. The bill will save some 140,000 positions in schools, and provides \$5-billion for the Pell Grant program.

"Education is an important part of any economic recovery," said Schrader. "The stimulus package provided a unique opportunity to improve our public education system by providing schools with the resources to hire quality educators. We need to position our youth and our displaced workers for the new post recovery economy."

#### Some of his recent accomplishments in Congress include:

- Securing resources for job-creating projects like a new employment center in Salem, more manufacturing jobs in Clackamas County, a new Oregon National Guard facility in Polk County, and bringing the NOAA Pacific Fleet and its hundreds of jobs to our Oregon coast.
- Correcting historic disparity in Medicare funding that hurt Oregon patients and their doctors.
- Helping Oregon families win back more than \$1.5-million in stalled Social Security payments, denied veterans benefits and delayed IRS refunds.
- Ensuring that veterans and their families get medical care and assistance as they transition into civilian life.

**State Representative Scott Bruun** averaged a failing grade when voting on issues important to AFT-Oregon members. As an investment banker, Bruun's voting record has sided with the wealthy and corporations over the needs of middle class Oregon families like high quality education and affordable healthcare.

In 2009, Bruun voted against the bi-partisan K-12 budget – allocating \$5.8-billion over two years to fund Oregon schools. And, he stood with big business seeking to continue to pay a \$10 corporate minimum tax. Bruun vocally opposed the American Recovery and Reinvestment Act which saved the jobs of thousands of Oregon teachers and education professionals.

While AFT-Oregon members thanked Kurt Schrader for his support of the education jobs package, Bruun has continually attacked the legislation as a "permanent tax increase" on multi-national corporations that ship American jobs overseas.

Bruun has a spotty record on supporting affordable health care for Oregon families. He opposed federal healthcare reform legislation that lowers the cost, increases quality of care for millions of Americans, and ends the historic geographic disparity in Medicare payments.

Bruun also opposed the 2009 "Healthy Kids" bill which requires Oregon health insurance companies to pay a little extra to expand state health care coverage to 80,000 uninsured children.

Recently, Bruun has spoke out strongly against the financial reform legislation passed earlier this year and voted against legislation that would have provided greater oversight on banks taking bailout money as a member of the Oregon Legislature (H.R. 2784, 2009 Legislature).



## AFT-Oregon recommends YES on Measure 71

Measure 71 would establish annual legislative sessions in Oregon. The economic crisis highlighted the need for these sessions to better govern our state in an efficient manner, and take care of any emergency and ongoing budgetary needs. In odd years the session would last up to 160 days, and 35 days in even numbered years. If passed, Oregon would join 45 other states that currently have annual sessions.
